2. The Office of Musikot Municipality invites electronic bids from eligible bidders for river protection (Gabion) work per specifications required. The overall estimate amount is Rs.12,60,462 (Excluding VAT and Contingencies). Specifications is uploaded in drawing portion of bid document under National Competitive Bidding procedures specified in Public Procurement Act and Regulations.

4. A complete set of Bidding Documents may be purchased from online portal of PPMO by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee till 31-03-2025 12:00.
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np. on or before (March-31)/ 31-03-2025 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at (March - 31)/ 31-03-2025,13:00hours at the Office of Musikot Municipality, Gulmi.
7. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of 30000 NRs. which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The bidder should fulfill the qualification criteria mentioned in bid document. The purchaser/ Office has full right whether to accept or reject the bidder's response according to prevailing laws.
