5. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np). on or before (May-30)/ 30-05-2025 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at (May-30)/ 30-05-2025 13:00 hours at the Office of Musikot Municipality, Gulmi.
7. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of 35000 NRs. which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The bidder should fulfill the qualification criteria mentioned in bid document. The purchaser/ Office has full right whether to accept or reject the bidder's response according to prevailing laws.
